CRMS statistics for the month of April show 161 customer requests registered with 67 requests remaining open and 94 being closed during the month. No complaints were received for April.


Debtors

The number of debts outstanding over 90 days remains at 59 with the amount at \$106k as of 30 April 2022.




Payment of Rates





Rates and charges in arrears are shown below. The level of arrears remains consistent for the same period in the prior year. As at, 30 April 2021 arrears of \$346k equated to 2.3% of rates and charges for the year 2020-21. Now at the 30 April 2022, arrears of \$361k equate to 2.4% of rates and charges invoiced for 2021-22.



Council have reinstated debt recovery procedures and hope to reduce the level of arrears over the next quarter.

The number of property assessments accessing hardship arrangements continues to remain steady.






Property Sales Data

LIC's are required to be provided by Council to property conveyancers to assist in calculating property settlement payments in relation to Council rates and charges outstanding against a property being bought/sold.

The volume of LIC's processed can provide an indicator of the buoyancy of the property market. The Mansfield Shire is currently experiencing a highly active property sales market and Council delivered a record amount of LICs for the 2020-21 financial year.



During April the announcement of Mansfield District Hospital as the preferred service provider for the Commonwealth Home Support Program (CHSP) for Mansfield LGA occurred.




The Great Victorian Rail Trail (GVRT)

A 4.7% increase in numbers on the rail trail with **8,600 users in April** compared to **8,198 users in March**. Numbers show a slight increase in people attending the Merton towards Bonnie Doon end and a slight drop on the Mansfield end.

Visitor Information Centre Visitor Survey

- ▶ 66% of visitors were aged 40 -65
- 48% were adult couples
- ▶ 88% were staying over one day with 33% staying two nights
- 54% of visitors were here for their first time
- Most popular things were Rivers, lakes and water. Bushwalking & outdoors. Attractions. Camping & Gravel riding.
- The most popular reason for visiting the information centre was for Maps and directions.

Outdoor Activation

Artist <u>Tim Bowtell</u> is working on an interactive artwork that will give visitors a photo opportunity and information on rivers within the towns in our Shire. The artwork is in the Mall (East end of High Street) and will be finished by early May.

Construction works have started on the amphitheatre at the Eastern end of the High St median strip. Construction will take around one week and the area will be fenced for an additional couple of weeks to ensure the grass can grow.

New removable umbrellas have been received and permanent in ground sockets have been installed in the median strip to ensure shade at the eastern and western ends. The umbrellas will not be permanently installed but will be available for use during events. New bench seats are being delivered in June.

A secured permanent music system will be installed in the median strip in June. The updated music system will allow community groups to have music performances or run music over the speakers without having to engage a sound technician saving considerable costs for the community.

The structure will be painted in Taungurung art by local artist <u>Talitha Annuscheit</u> in July.

The new **bin surrounds** in Jamieson, Goughs Bay, Botanic Park and Tolmie will also have Taungurung art by Maddi - Chlo & Co Creatives.

Shade structures will be installed over and adjacent to the Botanic Park playground in June. This will impact access for approximately one week and notice of these works will be provided to the community.

Most of the project works will be completed by June 2022 with three projects receiving an approval for a few items to be completed in July and August 2022. A meeting and tour of the projects was conducted with the state funding body (DJPR) on 3 May.

The Mansfield Engage platform has been updated to ensure the community is being kept up to date. Facebook posts and a media release have been created.

Events

Through the month of April council has supported the following events:

Alley Arts – 1 April

Through the Community Resilience and Recovery Funding grant, Arts Mansfield received \$25,000 for the purpose of Alley Arts. Council also assisted with in kind support in the form of waste and equipment.

Magda Szubanski Documentary – 8-10 April

Council was successful in our pitch for Mansfield to be a location for an upcoming ABC Documentary around heart health hosted by Magda Szubanski. Filming took place from 8-10 April with a special Heart Health event on Saturday 9 April. The feedback was great from the filming crews regarding Mansfield as a town and all the wonderful people we have in town. They will be back at the start of May for further filming and then hopefully we will see Mansfield on our screens soon!

Council supported this by facilitating venues for the film crew to use, supplying a sound technician for the event and access to event equipment free of charge.

Merton Campdraft – 9 – 10 April

The annual Merton Campdraft was held at the Mansfield Showgrounds and Council supported by funding JD's Water Cartage over the weekend. The Campdraft helps raise funds for upgrades, maintenance and running costs of the showgrounds. Our support ensured the continuation and improvement of this organization and grounds.

Day On High – 24 April

Returning from a two-year COVID absence, the annual Mansfield Winemakers Day On High was deemed a great success attracting big numbers and receiving positive community feedback. Council supported this event with a donation of \$2,000 to assist with entertainment and equipment including in kind support.

Council Business Support

Two business support newsletters, including COVIDSafe updates, were sent directly to 454 local businesses in April.

Business Concierge Program - Business Contact and Support

The Business Concierge Program has conducted 93 contacts (combining face to face, phone and email contacts) through the month of April.

Staff shortages are still an issue for businesses. As per previous periods, the sectors most affected are hospitality, food and beverage and retail. Businesses are continuing to close for short intervals to provide rest for staff at all levels.

The housing shortage continues to pose a major problem when trying to attract and/ or maintain applicants to advertised positions. This is being reported across all sectors.

COVIDSafe Management Guidance / Information enquiries have reduced during April with the ongoing reductions to most of the previous health requirements.

The funded Concierge program is scheduled to finish at the end of May.

Business Recovery Advisory Services

Council continues to partner with State Government funded program, Business Recovery Advisory Services (BRAS) as they assist Council in supporting the business community. BRAS report to the Minister for Employment and Small Business, along with distribution of their reporting to numerous State Government Departments, and their provision of funded consulting services provides excellent support to our local businesses and Business Concierge Program.

Mansfield Shire Councils Economic Development Unit has provided the following material for the April report to the Minister.

- ▶ SME's are continuing to have difficulty finding appropriately trained staff. Hospitality, food and beverage, and retail are affected the most.
- Housing shortage impacts include virtually nil rental accommodation for new staff.
- Businesses would welcome training opportunities for staff or job seekers via GOTAFE, MACE and other Training Service Providers for retail, hospitality, trades & services, and accommodation sectors. The provision of short certificate courses, whether introductory or advanced, to assist business with their recruitment.
- Mansfield Shire Council continue to seek remedy to poor / patchy / nil network coverage, limiting business investment / opportunity and impacting public safety. Advocacy to Telco's and the Indi Telecommunications Advisory Group and Federal Member for Indi Helen Haines MP continues. Issues with connectivity also affect uptake to digital literacy and digitalisation programs.
- Some businesses are re-investing in their businesses to pivot or re-align themselves with the changing market and the custom serge of visitation peaks. Some have undertaken major capital investment to vary their offerings, their buildings or expanded their locations.

Better Approvals

There were 3 enquiries around the Better Approvals process in April via the Mansfield Shire Council website

GOTAFE Mobile Campus

The Mobile Campus was in Mansfield 6 April to 9 April and engaged with 37 enquiries during their stay. This increase in visitation included 19 course enquiries, 14 career consults and 4 stakeholder visitors. The increase has motivated GOTAFE to request further visits to Mansfield in August and October, with a view to be located more closely to Mansfield Secondary College to assist with student enquiries.

Library

Refurbishment Update

Preparation during April:

- Weeding/purchasing items for the collection, ensuring that each section is the correct size for the new shelving capacity.
- clearing out storage areas.
- organising removalists.
- assessing shelving options to obtain best value for money.
- working with Friends of the Library to purchase furniture.
- planning for the limited library service to be run from the VIC.
- Coordinating with HCLN and Libraries Victoria so that Mansfield patrons will continue to have full access to items from Victorian Libraries.

Author visits focusing on local history

Peggy Aeschlimann presented an enthusiastic and well researched lecture on the remarkable philanthropist Anne Fraser Bon. Anne lived at Wappan Station in the late 1800s and was a fierce advocate for Aboriginal people. 50 people attended.

Grantlee Kiezla, a prolific and well respected historian/author, spoke about his recent release, 'The Kelly Hunters'. In this book, Grantlee writes about the lives of the men that were part of the search party for Ned Kelly prior to his arrest. The evening was hosted by Friends of the Library. 48 people attended.

School Holiday Unicorn Adventure

Over the school holidays, the Mansfield Library held a special Unicorn Adventure for all the little Unicorn lovers of Mansfield and beyond!

Over 130 little Unicorns and their grown-ups took part in a magical self-guided journey of Unicorn activities, ranging from making a Unicorn headband, finding your Unicorn name, playing pin the horn on the Unicorn and even counting the Unicorn poo!



The activities focused on fine motor skills with the colouring of the detailed Unicorn headband, early literacy skills using the first letter of the alphabet to find their Unicorn name, early numeracy skills with the counting of the Unicorn poo, encouraged physical activity with the Unicorn exercises and character/picture recognition finding the Unicorn book covers.

Great feedback was received and the smiles on our little Unicorn faces said it all! Some participants even returned a second time.
