


Bonnie Doon Wastewater Management Facility and buffer zone


# MANSFIELD PLANNING SCHEM






## Upper Delatite Wastewater Management Facility and buffer zone

DELWP and Mansfield Shire Council are undertaking a review of the Mansfield Planning Scheme as required under Section 12B of the *Planning and Environment Act 1987*. This will result in a report for the Minister for Planning and a planning scheme amendment to update local policy and provisions to reflect the findings of the review.
