# 1. Customer Service

### Monthly Customer Request Management System (CRMS) Report – May 2022

CRMS statistics for the month of April show 136 customer requests registered with 53 requests remaining open and 83 being closed during the month. One complaint was received in May. The complaint was pertaining to impact of works to the roundabout on the corner of Highett Street and View Street.

The majority (24%) of total requests opened were for Road Maintenance (Field Services) Road Maintenance requests consisted of (in order of frequency):

- Roads Corrugation
- Potholes
- Drainage

- Limb/Tree removal
- Missing sign
- Weeds and Vegetation

Asset Management (24%) was the second largest group. Asset Management Requests consisted of (in order of frequency):

- Building Property Maintenance
- Public Conveniences
- Public Lighting

At the time of the report there were 12 overdue service requests. Overall organisation performance is 91%.


### Debtors

The number of debts outstanding over 90 days remains at 52 with the amount at \$193k as of 31 May 2022.




### **Payment of Rates**





Rates and charges in arrears are shown below. The level of arrears remains consistent for the same period in the prior year. As at, 31 May 2021 arrears of \$326k equated to 2.2% of rates and charges for the year 2020-21. Now at the 31 May 2022, arrears of \$339k equate to 2.2% of rates and charges invoiced for 2021-22.

The number of property assessments accessing hardship arrangements continues to remain steady.






### **Property Sales Data**

The number of Land Information Certificates (LICs) processed annually (and as at, 31 May for the current year) are shown below. LIC's are required to be provided by Council to property conveyancers to assist in calculating property settlement payments in relation to Council rates and charges outstanding against a property being bought/sold.

The volume of LIC's processed can provide an indicator of the buoyancy of the property market. The Mansfield Shire is currently experiencing a highly active property sales market and Council delivered a record amount of LICs for the 2020-21 financial year.




# 9. Community Health and Wellbeing

# **Financial Counselling**

Financial Counselling clients come from a range of socio-economic backgrounds. They also come from a wide range of ages. During May 2022 clients ranged in age from their thirties, to their eighties.

# **Youth Services**

Youth services successfully applied for the Victorian Youth Fest 2022 funds, receiving \$2,000 to for a Skate competition in September 2022.

The Youth Centre is currently providing space for Senior Citizens, the Men's social group and the Friends of the Library.

Staff have been visiting the schools to deliver the resilience project workbooks and to take the time to talk about their current activities, how we can support them and opportunities for engagement.

# **Integrated Family Services**

In May 2022 Integrated Family Services have made a concerted effort to meet with key stakeholders in the community to ensure that potential referrers into the program are aware of the referral process, that we are now fully staffed and have vacancies for families. Whilst the period since the new referral process has showed slowed allocations into the program, efforts to engage with the community and The Orange Door are proving successful, and referrals have recently picked up. This is positive news for the families of Mansfield who are supported by this service.

May has seen challenges in staffing especially within the Community Care Worker team with an increase in sick leave related to flu and COVID and several staff resigning from their CCW role.


CCW's and office staff interested in transitioning to Mansfield District Hospital (MDH) underwent interviews with employment opportunities offered with MDH from 1 July.

# 10. Visitor Services


### The Great Victorian Rail Trail (GVRT)

A 14.9% decrease in overall users on the rail trail with **7,408 users in May** compared to **8,600 users in April.** With the change in weather this drop is not unusual or of concern. An increase at the Mansfield end can be attributed to the Mother's Day fun run and Mansfield Marathon at end of May.



The Great Art Doors project has entered its final selection stages with artists recommended for each location through the panel. The next step is informing those successful artists and then final consultation with the community control group.

The Rail Trail has seen two successful events in May with the Mother's Day fun run and the Mansfield Marathon. Both were completed successfully however highlighted some areas of concern for those planning events around traffic management and safety. These will be communicated through our events website pages for events on the rail trail. The level of safety that is needed to hold these events on the rail trail will be higher than it has previously as events grow.



### Visitors to the Mansfield Visitor Information Centre (VIC)

There was a decline in the VIC statistics for May 2022. Weather most likely played a part in this with the cold settling in towards the end of May and a drop in visitor numbers. Naturally lower visitations mean less merchandise sales and also heading into Winter map sales drop.

### Merchandise sales – last three months

- March \$1,613.20
- April \$2,837.35
- May \$1,180.20

### **Visitor Survey**

The Visitor Information Staff have recommenced gathering information from visitors to the VIC. Looking at age ranges, origin of travel, reasons for travel and more. These figures are from November 2021 to date.

- 69% of visitors were aged 40-65
- 51% were adult couples
- **11%** were staying over one day with **34%** staying two nights and interesting figures of longer stays for the month with **19%** staying 3 nights and **25%** staying over 3 nights
- 56% of visitors were here for their first time
- Most popular activities were Rivers, lakes and water. Bushwalking & outdoors. Attractions. Camping & Gravel riding.
- The most popular reason for visiting the information centre was for Maps and directions.

## **Projects**

### **Outdoor Activation**

Artist <u>Tim Bowtell</u> has completed his works at the east end of High Street in the Mall. The community were very pleased with the results and multiple photos of the interactive works have appeared already on social media.

Local company Tectonic completed works on the amphitheatre at the east end of the High St Median Strip. This project is scheduled to have an pening event once the grass has settled in to avoid mud.

A secured permanent music system will be installed in the median strip in June/July. The updated music system will allow community groups to have music performances or run music over the speakers without having to engage a sound technician saving considerable costs.

The structure will be painted in Taungurung art by local artist <u>Talitha Annuscheit</u> in July.

The new **bin surrounds** in Jamieson, Goughs Bay, Botanic Park and Tolmie will also have Taungurung art by Maddi - Chlo & Co Creatives.

Shade structures will be installed over and adjacent the Botanic Park playground in June. This will impact access for approximately one week and notice will be provided to the community.

Council has gained support from State Government to reallocate some outdoor activation funding to enable the purchase of a bike repair station for the start of the Great Victorian Rail Trail. This should be installed by end of June.

Most of the project works will be completed by June 2022 with a few items remaining for completion in July and August 2022.

Council's Engage platform has been updated to ensure the community is kept up to date. Facebook posts and a media release will be organised as required.

## **Events**

Through the month of May Council has supported the following events:

### Mother's Day Classic Fun Run – 8 May

Assisting with the planning of the annual Mother's Day Classic Fun Run. The route had to be changed due to works on Withers Lane and increased traffic flow with the development of Stockman's Rise. Working with the organisers we facilitated a new course with safety in mind and assisted with signage and information.

### Mansfield Marathon – 29 May

Council assisted the organiser with permit applications to Vic Roads for activities on the Midland Link. This included sourcing a traffic management company for them to use. We also provided in kind support with set up of traffic management and safety signage, loan of equipment and general planning. The event was a success with over 200 entrants.

### Jamieson Trailer Reversing Competition – 28 May

This fun and quirky event sprung up from a new resident to Jamieson community group, an offspring of the Jamieson Community Group. Looking for ways to bring men together without a focus on alcohol the group has recently done some events such as movie screenings which close to 40 attendees. Council assisted with insurance payment for the event of \$800 and assisted with permits and facilitation of requirements. The event was a great success with over 200 people coming along to watch the fun. Council will continue to work with the group on ideas to grow this fun event next year.

### **Council Business Support**

Two business support newsletters, including business grant, program, workshop and COVID Safe information, were emailed directly to 454 local businesses in May.

The reported figures below are the average open rate and click rate for the newsletter.

May 2022 open and click through figures are higher than industry benchmark and are slightly higher than the previous months numbers. This is a good indicator of the value of the newsletter and information to recipents.

#### **Business Concierge Program - Business Contact and Support**

The Business Concierge Program, funded by State Government Department Justice Precincts and Regions (DJPR), is coming to completion.

Councils are asked to provide feedback via a survey which Mansfield Shire Council completed in May. Survey details and some of the registered feedback will be assessed and published by DJPR during June 2022. Council's Business Concierge Team registered 92 contacts (face to face, phone and email contacts) through May 2022.

Reports to DJPR in May included the following insights:

- Customer facing sectors (Retail, Hospitality, Accommodation) with staff shortages were getting poor response to traditionally advertised job vacancies (Local paper, Internet, social media and window posters).
- As is being reported widely across Victoria, many applicants from outside Mansfield Shire were unable to find suitable or long-term accommodation.
- Local applicant numbers were low across all sectors.
- Hospitality businesses continue to close periodically to rest healthy staff as sick leave (and isolation due to COVID close and social contact) continues to impact rosters.
- Owners, managers and staff continue to be challenged with fatigue and the need to constantly re- roster.

Mansfield Shire businesses commented on poor connectivity during higher visitation periods. While the federal election raised issues of poor connectivity in many regional areas and although Indi has been a major recipient of funding over the past decade, we still require further advocacy to achieve a standard of service that is acceptable for Mansfield Shire's unique population and topography.

Supply of goods and services has been a key issue during May, with issues relating to logistics and building and construction materials, such as timber and some plumbing and electrical issues.

### **Business Support Services**

From 1 June 2022, Business Victoria in collaboration with Monarch Institute are providing a new delivery of service model that provides virtual business advice sessions. Due to funding changes, Business Recovery Advisory Services no longer provide business community support.

Business owners and those wishing to start a business can receive one free 45-minute session with an expert who can advise on:

- marketing, website, digital marketing strategies
- employing and managing staff
- · financial strategies to increase sales and profits
- the next steps with a completed business action plan.

Council will promote these services to local businesses, which can access a general adviser or obtain more specialised advice.

### **Better Approvals**

There were four enquiries around the Better Approvals process during May.

- One via the Mansfield Shire Council website
- One via direct email enquiry
- Two via telephone enquiry

Enquires comprised:

- requirements for business advertising
- assistance with funding and requirements for new business
- assistance with requirements for new tourism and cultural business

All enquiries were relatively preliminary. Two of these contacts wanted to discuss opportunity around funding and where to look, one was about a proposed business and the fourth was a new business within existing premises with some change of use aspects. Discussions with these enquiries are ongoing with some interaction with funding bodies and other Council departments around permit requirements.

#### **GOTAFE Mobile Campus**

The Mobile Campus is now confirmed to return to Mansfield in August 2022.

### **Business Victoria – Small Business Bus**

The Small Business Bus is booked in to visit Mansfield in November 2022.

## Library

### Refurbishment Update – May

The Library refurbishment will take place in two stages.

- During the first stage, construction will begin along the front exterior of the building. The library will remain open and access to the public will be through the rear carpark.
- The second stage will occur towards the end of the 2022 calendar year and include all internal aspects of construction and refurbishment. A limited library service will be available to the public from Council's Visitors Information Centre.

Risk assessments are being undertaken for both the rear entrance to the Collopy Street building and the VIC.

Council is currently waiting to find out the current lead time on windows. This will determine the start date of the first stage.

Library staff are working with Friends of the Library to purchase a self-serve kiosk.

#### What am I reading?

This is Mansfield Library Facebook project that aims to promote reading, highlight individuals/organisations and connect the community through sharing.

11 community members have been featured so far on the Mansfield Library Victoria Facebook page.





### On 24 May, the Library participated in the 2022 Victorian Public Library Census.

The aim of the census is to provide a snapshot of current public library use: every library service, every branch, and every user. The Census, together with 2022 Public Libraries Victoria Network Survey will inform strategic and service planning and advocacy.

Council celebrated **National Simultaneous Storytime** by running two sessions at the Farmhouse Kindergarten. NSS is a national literacy initiative in its 22<sup>nd</sup> year. Every year an Australian picture book, is read simultaneously in libraries, schools and many other places around the country.

#### 1,000 Books before school

# 11. Communications

### Website Launch
