Having considered all submissions to Amendment C44 under section 22 of the Act; COUNCIL Resolves to:

- Adopt Amendment C44 to the Mansfield Planning Scheme, in accordance with section 29 of the *Planning and Environment Act 1987*, with the following changes, in accordance with the attached Amendment C44 package:
  - Amendment to the explanatory report per Department of Transport's request.
  - Amending proposed Clause 21.09, *Mansfield Township*, to add a new strategy to Objective 14 as follows:
    - Strategy 14.8: Manage transport movements and access interfaces with the surrounding transport network to improve access arrangement and navigation to and from the site for all transport modes.
  - Amend the Incorporated to plan to show bus zones and additional accesses as indicative only, add details about the heritage structures on the masterplan, and include reference to the Commercial 1 and General Residential 1 Zones on part of the land.

• Submit Amendment C44 to the Mansfield Planning Scheme, together with the prescribed information, to the Minister for Planning in accordance with section 31 of the *Planning and Environment Act* 1987.
