- 4. Having considered the report of the independent panel to consider submissions to Amendment C51mans Part 2 under Section 27 of the Act;

#### Mansfield Shire Council resolves to:

- 1. Adopt Amendment C51mans Part 2 to the Mansfield Planning Scheme, in accordance with Section 29 of the Act, with changes to include recommendations of the independent panel, as follows:
- a. Rezone the land on the northern side of Curia Street, Mansfield, between Apollo and Elvins Street, known as 19 55 Curia Street, the rear of 2 4 Station Street and 8 10 Station Street as outlined in the attached Amendment C51mans Part 2 package.
- 2. Submit Amendment C51mans Part 2 to the Mansfield Planning Scheme, together with the prescribed information, to the Minister for Planning in accordance with Section 31 of the Act.
- 3. Advise all submitters to Amendment C51mans Part 2 of Mansfield Shire Council's adoption of the amendment.

- 2. At point 5.1.1, amended wording to reflect the retention of a vineyard on site to the satisfaction of the Responsible Authority.
- 3. At points 5.5.1, 5.5.2 and 5.5.4 include wording to require retention or relocation of part of the vineyard, to the satisfaction of the Responsible Authority.
