19.1 Award of Tender – HVAR Stage 2 Construction

Councillor Steve Rabie/Councillor Mark Holcombe:

THAT COUNCIL

- 1. Awards a lump sum contract for the HVAR Stage 2 Construction to North East Civil Construction Pty Ltd in the amount of \$2,381,362.76 (excl. GST).
- 2. Approves a 10% construction contingency amount of \$238,136 (excl. GST).
- 3. Approve the allocation of \$591,593 from the Local Roads and Community Infrastructure Program Phase 3 Extension to this project, and the submission of a project nomination to the funding program for approval.
- 4. Under Section 112 of the Local Government Act 2020, Council authorises the transfer of land by agreement with the property owner concerned a section of land, as determined by survey from the land at 104 Dead Horse Lane, Mansfield, described as Lot 1 on Title Plan 232231, Certificate of Title Volume 08234 Folio 273 as a road reserve to incorporate the works for Dead Horse Lane, to the satisfaction of the Responsible Authority.
- 5. Under Section 112 of the Local Government Act 2020, Council authorises the transfer of land by agreement with the property owner concerned a section of land, as determined by survey from the land at 50 Mt Battery Road, Mansfield, described as Lot 21 on Parish Plan 3056 as a road reserve to incorporate the works for Mt Battery Road/Greenvale intersection, to the satisfaction of the Responsible Authority.
- 6. Makes this resolution public by including it within the public minutes of the Council meeting.
